#### Pledge:

**Public Comment:** Mr. Jay Estus and Mr. Robert Estus from the Green Street Family Farm and Sawmill of Chesterfield stated that they are not in favor of opting out of the Cannabis Legislation. They gave reasons to opt in - such as it would put illegal drug dealers out of business, it could be regulated, other towns who opted out wish they had not. They would like to be able to grow marijuana starting in March so they could get a 2 season grow and it would help their struggling farm.

Supervisor Monty stated that the Board can vote to opt out, but if residence don't agree with the resolution they can get signatures to change the law.

A motion was made to adjourn the Public Hearing at 7:10 p.m. by Dave Blades and seconded by Steve Denton, 0 opposed, motion carried.

Kevin Denton stated the Highway department is losing a laboror as of the 23<sup>rd</sup>. The one truck is in Glens Falls waiting for the box to be put on. The wind storm knocked down about 8 to 10 trees and they have been cleaned up. One road was closed overnight due to power lines down over the road.

Lanita canavan stated the Deer Head Cemetery has a few trees down.

Supervisor Monty stated a tree is down at the entrance to Thrall Dam.
