Resolution 18-1-1

Resolution to set the date of Monthly Meetings

RESOLVED, The Town Board shall hold regular meetings on the second Tuesday of each month at 7:00 P.M., and special meetings may be called by the Supervisor by giving at least two days of written notice to the Board.

Youth Commission Report:

Meeting was held last night, working on a Stewarts grant for basketball uniforms, this Sunday is a trip to YMCA, Hope to get last year Director again for this summer, They want to increase the Director salary from \$2500 to \$2860., they would like a storage shed, Planning a Winter Carnival in February, Ice Skating on the 19th, want to update By-Laws, Have received questions concerning youth participating if not meeting certain academic requirements, Jim stated the Youth Program is a Town program not a School Program, Dave Suggested the Youth Commission could consider some kind of homework study group, Questions on if Background checks are required on coaches. Vanessa will check with the Youth Bureau.

The Town has received a FEMA award for Stella for \$13,523, \$10,112 from the Feds and the rest from the State. Jim recommended this money go into the equipment line.

A motion was made appointing Larry Hulbert to act as a liaison on the water project by Dave Blades and seconded by Jeff Scott – 0 opposed – motion carried

A motion was made to accept a one year lease with the Children's Development Center for 650 a month for the bottom floor of the old school building by Dave Blades and seconded by Steve Denton – 0 opposed – motion carried

A motion was made to accept \$375 a month from ACAP to rent the upper space at the old school by Lanita Canavan and seconded by Dave Blades – 0 opposed – motion carried
