Present: Councilors: Steve Denton, Dave Blades, Lanita Canavan, Jeff Scott and Supervisor James Monty

Called to Order: The meeting was called to order by Supervisor Monty at 7:00 p.m.

# Pledge of Allegiance

**Guests:** Patty Bashaw from the Elizabethtown Lewis Ambulance Squad went over their budget. This year they are requesting from the Town of Lewis \$52,796.00 up \$10,000. From last year. She also stated they would like to receive the full amount in February instead of having it split. Supervisor Monty stated that the Town would like minutes and monthly financial reporting to account for the Town monies. Patty stated she had discussed that with the Auditor and that is something they can provide.

Jean Dickerson the Town Historian had a request from resident Steve Ives for a historical marker for his house. Jean stated this would have to go through the Pomroy Foundation and she would like the Boards permission to send a letter of intent.

A motion was made to give Jean Dickerson approval to submit the application by Steve Denton and seconded by Lanita Canavan, O opposed, motion carried.

Ms. Nancy Campbell would like support from the Town Board of Lewis to apply to the US Board of Geographic Names to have the name of Mt. Discovery changed to Mt. Inez as this was already done by the Lewis Town Board in 1916 or 1917, but the application was never filed. Supervisor Monty stated the change would be posted in the paper and after a 30 day comment period the application can be filed.

A motion was made to support Nancy Cambell in the filing of the paperwork, after 30 days, to change the name of Mt. Discovery to Mt. Inez by Dave Blades, and seconded by Lanita Canavan, 0 opposed, motion carried.

**Approval of August 20, 2019 Meeting Minutes:** A motion was made to approve the August 20, 2019 meeting minutes as amended by Steve Denton and seconded by Lanita Canavan, 0 opposed, motion carried.

**Supervisor's Financial Report:** A motion was made to accept the Supervisor's financial Report by Jeff Scott, and seconded by Lanita Canavan, 0 opposed, motion carried.

**Public Commentary:** Kaylee Dasile from NYCO reviewed the permits and stated they will be applying for a hauling extension from the APA for an additional 9 weeks and she will let the Town know if they get the approval.

**DPW/Water Report:** Kevin Denton stated the inside of the Salt Shed is scheduled to be blacktopped on Friday. They are going to start drawing winter sand. The tires on the grader are going bad and will need to be replaced, under State Contract the tires would cost between \$1300 and \$2000 a piece, but he has another source he can get them from for \$895. A piece. The Water meters are up and running.

- Public Health Water Report came back normal and usage is down, due to leaks having been fixed.
  - A motion was made to accept the water report by Dave Blades and seconded by Steve Denton, 0 opposed, motion carried.

Westport and Elizabethtown have been discussing the color of uniforms. Dave Blades expressed concerns over 3 year olds playing with 5 year olds. Supervisor Monty stated that is a concern with safety. A motion was made to accept the Youth Commission Meeting minutes by Dave Blades, and seconded by Lanita Canavan, 0 opposed, motion carried.

- BAR HM Timber They are looking to sell 2600 acres of land to open space Institute, who will
  then turn it over to the State, 400 acres are in Lewis and 2200 are in Chesterfield. Discussed the
  480 A not being paid back to the Town, and concerns of giving up land. The Town cannot stop
  the sale, but can let the Town's positon known. The Board will discuss the sale again next
  month.
