# Regular Town Board Meeting

# September 12, 2023

#### Lewis Town Hall

**Present:** Counselors Lanita Canavan, Terry Pulsifer, John Blades, Steven Denton and Supervisor James Monty.

**Called to Order:** The meeting was called to order at 7:00 PM by Supervisor Monty.

# Pledge of Allegiance

Guests: Carolyn Schier, Board President with Elizabethtown-Lewis EMS, asked the Board to consider passing a resolution to form an Ambulance District. She stated they are struggling to find coverage and to make ends meet. Many Ambulance squads are moving towards an Ambulance District which would mean it'd be a separate line item on the tax bill. It could be formed more like a water district than a fire district. This would cover the Lewis-Elizabethtown district still. She also stated the second ambulance is old and starting to cost money to fix. Ethan Farmer stated the repairs this year alone cost roughly \$8,000.00 to repair. They are considering selling it to pay bills but prefer not to as there have been multiple calls recently.

Supervisor Monty knows the need is there but doesn't think it'll fit in the budget within the 90-day time frame needed. Carolyn stated the Board would need to pass a resolution first to go to the next step and has to be a 3 out of 5 approval.

Counselor Canavan spoke and has financial concerns and recommends the Elizabethtown-Lewis EMS to have a CPA audit. They stated they have an accountant doing their books but is not CPA certified.

Carolyn stated they are looking for roughly \$400,000 for the upcoming years proposed budget. She stated the numbers they are mentioning are based solely on the proposed budget for 2024 minus estimated revenues.

Counselor Denton thinks there are tons of questions that need to be answered and he feels the Board should pass a resolution as it allows for further conversation.

Supervisor Monty wants to pass the Resolution of approving of a map plan report regarding the consideration of establishment of an Ambulance District for the Town of Lewis. A motion was made to accept the resolution by Steve Denton and seconded by Terry Pulsifer, 0 opposed, motion carried.
