Kevin Denton stated re-seeding has been done from the water project, and DPW will be black topping the week after next.

Kevin said he is not in favor of giving up part of the Hale Hill Road that the owner of the Missile Silo has requested. Kevin stated that the Town would lose money from the State if they give up the 825 Feet.

Counselor Blades suggested maybe the property owner could reimburse the Town yearly the amount that would be lost by giving up that portion of the road and Kevin could discuss that with Supervisor Monty.

Kevin stated the water samples came back normal. A motion was made to accept the Water Report by Dave Blades and seconded by Steve Denton, 0 opposed, motion carried.

Counselor Blades asked how the Town water would be impacted when the school builds on the Thrall Dam property.

Counselor Scott stated that Supervisor Monty said it was discussed at the School Board Meeting and that we have enough water to support it.

Kevin Denton said it would be comparable to the Public Safety Building usage.
